Meeting Minutes

March 3, 2016

Roll Call

The meeting of the Committee was called to order at 7:06pm by Chairman and Trustee Kelvin Jones. A quorum was established. The agenda was adopted with the following changes: discussion of Parks and Recreation staff, discussion of use of the refrigerator by outside groups; discussion and approve consideration for new programs, i.e. a junior dance and participation in a Special Olympics program.

The minutes from the January 7, 2016 and February 4, 2016 were approved as presented. It was moved and seconded.

A recap of the February, Open Gym Program was discussed. It was well received. We discussed how to increase awareness of the event. It was approved that this activity will be a monthly event.

Plans for the Easter Egg Hunt was discussed in length. It was decided to host the event March 26th and that Committee members will meet at the community center March 25th to stuff the eggs. Trustee Jones will research the location of the Easter Bunny suit, retrieve it and have it cleaned. We established a schedule of activities for event day and agreed that Light refreshments will be provided. It was further agreed that Marva will develop a flyer once entertainment is finalized.

New Business

1. Use of the refrigerator: Trustee Jones will meet with the planner of the Panera Bread Distributors to discuss usage.
2. Staff Member's Participation at events: Trustee Jones will determine if this can occur and what is the financial impact.
3. Special Olympics: The Committee voted to explore the possibility of involvement of youth and residents with disabilities taking part in a program. Suggestions were made to include surrounding Villages as participants. Marva will research and bring back findings to the Committee.
