Re: Freedom of Information Act Request

Dear Mr. House:

Our law firm represents the Village of Sauk Village ("Village"). Thank you for writing to the Village with your request for information pursuant to the Freedom of Information Act ("FOIA"), 5 ILCS 140/1 *et seq.* Your FOIA request seeks the following documents:

1. All receipts and copies of the calendar where events are logged for the months of January 2016-September 2016. With dates and names of organizations or people that rented the facility.
2. How much money was collected for the Easter Egg hunt a copy of all receipts, donations, deposits.
3. What is the balance in Parks and Recreation as of September 20, 2016?
4. How much money was collected from the vending machines, pop etc. Monthly. Who supplies the pop to the machines? A copy of the purchase of the pop monthly or as refilled date and amount.
5. How much money was collected from the concession sells for all the open gym events.
6. How much money was collected from the monthly line dancing program monthly.
7. How many times have the Ed Pasel Community Center been rented out and How much money was collected from each rental and who rented it, with what form of payment was made per event. The renters name, form of payment and receipts.
8. How much money has been collected to participate for the regular gym, I.D.'s etc. copy of all receipts?
9. I am requesting to see how much they have in petty cash and all receipts for petty cash.
10. I am requesting a copy of Parks and Recreation ledger or all expenses and revenue or grants etc.
11. How much money has been collected, and or spent, for the all the Friday night UNO games and a copy of all receipts including Friday September 16, 2016?
12. Copies of all checks, money orders or cashier's checks received from renters of the facility.
13. A copy of all the sign in sheets, agendas and minutes for every parks and recreation meeting from January 2016-September 2016.
14. A copy of all sub-committee members and their residency, if they live in Sauk Village? How many meetings they have missed this year.
15. A copy of any and all the meetings that were video-taped and dates of the video-taped meetings.
16. A list of all volunteer's names with a background check for regular events that have including supervising children including open gym.
17. A list of volunteers with background checks that supervised children during the Summer Camp.
 - a. Also, a copy of all receipts, checks, or amounts in cash that was collected for registration

fees, etc. How much money did Parks and Recreation profit from the camp? How many children?

18. A copy of the light bills during the months of the camp. What were the camp dates?

You are hereby notified that your requests have been determined to be a "voluminous request" within the definition of FOIA, as it is a request that is a combination of individual requests that total requests for more than 5 different categories of records in a period of 20 business days. 5 ILCS 140/2(h). As a result, you will have 10 business days from the date of this letter to specify whether you would like to amend the request so that it is no longer a "voluminous request."

You have the right to have the Village's designation of your FOIA request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General:
